Applicants will not have priority over other applicants and only a limited number of places will be offered to suitable mature applicants.
- Applicants need to provide the related documentations for verification if they are invited to attend the interview.

Personal Information Collection Statement

- (1) The information collected from the application, including the name, phone number, mobile number, email address, correspondence address and education level, will be used for the following purposes:
 - (a) for processing and selection of applications for admission to VTC programmes in the intake year; and related purposes;

- (3) In accordance with the Personal Data (Privacy) Ordinance, an applicant has the right:
 - (a) to check whether VTC holds his / her personal data;
 - (b) to request a copy of such data; and
 - (c) to require VTC to correct any of the personal data which is inaccurate.

Sufficient information will need to be provided to establish identity, otherwise VTC shall refuse to comply with the request.
