SECTION I

INTRODUCTION

The Automobile Training Board

1.1 The Automobile Training Board of the Vocational Training Council is appointed by the HKSAR Government to be responsible for determining the training needs in the automobile industry and to recommend to the Vocational Training Council measures to meet the needs. Membership of the Automobile Training Board is at Appendix 1.

The Manpower Survey

- 1.2 The manpower survey of the automobile industry was conducted by the Automobile Training Board during the period from 20th February 2006 to 20th April 2006. The aim of the survey is to collect up-to-date manpower information in the principal jobs of the automobile industry. The survey was carried out with the assistance of the Census and Statistics Department.
- 1.3 the following information was collected from the survey:
 - (i) the number of employees at the time of the survey;
 - (ii) Employers' forecast of the total number of employees by April 2007;
 - (iii) the number of existing vacancies;
 - (iv) the number of employees under training;
 - (v) the average monthly income of employees; and
 - (vi) Employers' views on the preferred education, training mode and training period of employees by principal job levels.

Scope of the Survey

- 1.4 The survey covered the following branches/sectors of the automobile industry:
 - (a) establishments engaged in the manufacture, servicing and repair of motor vehicles and recorded by the Census and Statistics Department under HSIC 3884 and HSIC 9513;
 - (Note: HSIC denotes Hong Kong Standard Industrial Classification)
 - (b) establishments recorded by the office of the Director of Apprenticeship of the Vocational Training Council;
 - (c) establishments maintaining a fleet of vehicles and having their own repairing facilities; and
 - (d) government departments and educational institutions.

Method of the Survey

- 1.5 In view of the limited resources, a stratified random sampling method was adopted to select 436 samples out of 2 236 establishments in the specified frame.
- 1.6 Two weeks before the survey, the survey questionnaires and supporting documents were sent to the selected establishments. During the fieldwork, interviewers from the Census and Statistics Department visited the selected establishments to collect the completed questionnaires and, where necessary, assist the employers in completing them.
- 1.7 After the survey, the completed questionnaires were checked and, where necessary, verified with the respondents before being processed by the Census and Statistics Department. The collected data were statistically grossed up to give the overall picture of the manpower situation of the automobile industry at the time of the survey.

Response to the Survey

1.8 Of the 436 establishments selected for the survey, 335 had supplied the required information. A total of 51 establishments were found to be either closed or ceased in operation. Another 24 establishments could not be contacted due to the change in address. The remaining 26 establishments were no longer engaged in the automobile trade.

Statistical Data

1.9 This report aims at presenting the vital manpower data collected from the fieldwork. This statistics should be read with care as they are initial data and subject to amendment. The Automobile Training Board will analyse the data and publish a full report on the survey in due course.

SECTION II

SUMMARY OF SURVEY FINDINGS

Number of Persons/Workers Engaged/Employed

- 2.1 The survey revealed that in April 2006, a total of 12 099 workers were employed in the principal jobs of the automobile industry in Hong Kong.
- 2.2 The distribution of workers according to the job level in the branches/sectors was as follows:

第一章

緒論

汽車業訓練委員會

1.1 職業訓練局屬下汽車業訓練委員會須根據職權範圍,確定業內的人力及訓練需求,並就發展訓練方案向局方提出建議,以應付業內所需。本會委員名單載於附錄 1。

人力調查

- 1.2 本會根據職權,於 2006 年 2 月 20 日至 4 月 20 日期間,進行汽車業人力調查,收集業內最新的主要職務人力資料,以評估本業人力架構及訓練需求。是次調查由政府統計處協助進行。
- 1.3 調查收集的資料包括:
 - (i) 調查期間的僱員人數;
 - (ii) 僱主預測 2007 年 4 月時的僱員總數;
 - (iii) 現有空缺數目;
 - (iv) 受訓僱員人數;
 - (v) 僱員每月平均收入;
 - (vi) 僱主認爲各主要職務僱員宜有的教育程度、訓練方式及訓練期。

調查範圍

- 1.4 是次調查包括汽車業內各門類/類別:
 - (a) 政府統計處紀錄中的汽車製造及維修機構 (香港標準行業分類3884、9513);
 - (b) 職業訓練局屬下學徒事務署紀錄中的機構;
 - (c) 擁有龐大車隊並自行負責維修工作的機構;
 - (d) 政府部門及教育機構。

調查方法

- 1.5 基於資源所限,本會採用了分層隨機抽樣法,在指定範圍內的 2 236 間機構中,選出 436 間爲調查對象。
- 1.6 調查表連同有關文件於調查前兩星期寄予選定機構。調查期內,政府統計 處職員到訪各機構,收取填妥的表格,並於需要時協助僱主填表。
- 1.7 調查完畢後,填覆的問卷均經複核,必要時並與有關機構核實,然後交由 政府統計處作資料處理。搜集所得資料經統計學方法倍大以反映出調查期間本業人力 的整體情況。

調查回應

1.8 436 間受訪機構中,335 間提供所需資料,其餘有51 間或已關閉,或已停止商業活動。此外,有24 間因搬遷而無法聯絡,而另外有26 間已改為從事非汽車業事務。

統計數據

1.9 本報告旨在列出實地調查所得的重要人力數據。不過,有關數據屬初步結果,或會再作修訂。本會隨後會出版另一報告書,詳列分析結果。

- 2.1 調查顯示,二〇〇六年四月時,本港汽車業各主要職務共有僱員 12 099 人。
